All India Institute of Medical Sciences (AIIMS), Jodhpur, Rajasthan, an apex healthcare institute established by an Act of Parliament of India under aegis of Ministry of Health & Family Welfare, Government of India, invites **Online bids in two bid system for** tenders for supply & installation of the Subscription for a year License for a Digital 3D Anatomy Software at the institute. You are requested to quote your best offer along with the complete details of specifications, terms & conditions.

Instructions:

- 1. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>.**
2. The complete bidding process is online. Bidders should be in possession of a valid digital Signature Certificate (DSC) of class II or III for online submission of bids. Prior to bidding, the DSC must be registered on the website mentioned above. For any assistance for e-bidding process, if required, bidder may contact the helpdesk at 0291-2740741.
- 3. Tenderer/Contractor/Bidders are advised to follow the instructions provided in the 'Instructions to the Contractors/Tenderer/Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>'.**
4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing the size of the scanned document.
5. The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay, this Institute will not be responsible.
6. Quotations must be in the enclosed prescribed Proforma on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative.
7. Rates must be quoted as per the format specified. Taxes extra, if any, must be written separately.
8. Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
9. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
10. The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tenderer on this issue shall be treated as agreed with this condition.
11. Bidder must quote product for only one company and should mention the specific company name; if bidder quotes for more than one company, the bid will be treated as unresponsive and will not be considered for further process.
12. Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
13. RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.

14. The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
 - a. Firm shall be registered with the Government of Rajasthan / Central Government.
 - b. The firm shall have valid VAT/ Sales Tax No. and IT PAN.
 - c. **The firm should not be black listed by any Govt. Agency/Dept.**
15. Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
16. The supplier may be asked to submit a sample of the product(s), which will be evaluated by a technical evaluation committee. The expenditure incurred for demonstrating the items will be borne by the supplier.
17. **Delivery Period** – 30 days from the date of supply order.
18. **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
19. **Payment Terms:** Payment will be made only after satisfactorily delivery, commissioning and inspection of material by the AIIMS Jodhpur.
20. **Disputes:** -In the event of any dispute or disagreement arising between the Supplier and any other department of AIIMS Jodhpur with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to the Director, AIIMS Jodhpur whose decision will be final and binding upon the Supplier.
21. AIIMS, Jodhpur reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the AIIMS, Jodhpur will be final in this regard.
22. AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.
