1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.

Technical details for the same are follows:- Technical specifications of Aneurysm clips: The instruments should be light weight, made up of non-magnetic Titanium/Cobalt alloy with ISO 9001 / CE / PIS or equivalent rating. The dimensions of clips may vary 5-10% from specification mentioned. All clips should be manufactured by same manufacturer and should be compatible with the Yasargil Clip Applicator available at operation theatre of AIIMS Jodhpur. It should be CE approved. The aneurysm clip should be made of Titanium/Cobalt alloy. The clip should be MRI safe. The blade profile should have pyramid like impression. It should be atraumatic. The clip should ensure even pressure on the complete blade surface. Each clip should have individual serial no. to ensure complete tracking of manufacturing process, material, closing force, sterilization process. The clip should be supplied in sterile pack. The Package of clip should mention article no, expiry date, closing force. The clip should be color coded.
