1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
 The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.

Specification of Infant Bassinet:-

- Should have removable baby bed.
- The infant cot should be made of single mould unbreakable polycarbonate material
- Infant cot should be easily removable for cleaning and should have holes in the bottom for draining of water & fluids.
- Size should be as follows:
- Length of the infant cot should be 765 mm (±5%)
- Width of the infant cot should be $400 \text{ mm} (\pm 5\%)$
- Depth of the infant cot should be 200 mm (±5%)
- Should have washable mattress made of high quality PU Foam
- Foam bed density should have minimum 26 Kg/m3
- Baby bed should be put in trendelenburg position
- Utility tray should be easily removable for cleaning and should have swivel facility
- Should have baby name plate holder
- Should have sturdy 4" Swivel castors (minimum 2 with brakes)
- Coating should be of epoxy/powder for scratch resistance & rust protection.
- The system should have an international (FDA/CE/IEC) approval.
