Sealed Quotations are hereby invited by the undersigned on behalf of the Director, AIIMS Jodhpur for Air Mattress with Pump for the Institute as per terms & conditions mentioned below. The filled quotations along with all the required document must reach in the office of the undersigned on or before 01.07.2020 05.00 PM. The Envelope containing the quotation would please be sealed and super scribed as under:-

1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. **The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.**
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in “**Quotation Box**” located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- Firm shall be registered with the Government of Rajasthan / Central Government.
 - The firm shall have valid GST/Other taxes and IT PAN.
 - **The firm should not be black listed by any Govt. Agency/Dept.**
- J) Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and

rejected accordingly. Any conditional quotation shall be rejected summarily.

- K) **Delivery Period** – within 30 days from Purchase order.
- L) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- M) **Payment Terms:** Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the AIIMS Jodhpur.
- N) **Disputes:** -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to the Director, AIIMS Jodhpur whose decision will be final and binding upon the contractor.
- O) AIIMS, Jodhpur reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the AIIMS, Jodhpur will be final in this regard.
- P) AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.

2. Special Terms & Conditions:

- A) **Bidder must quote the product as per specification provided in Annexure 1.**
- B) **Catalog must be attached with quotation for technical evaluation.**
- C) **The supplier may be asked to arranging demonstration of their equipment for which rates have been quoted, to the AIIMS Jodhpur, if required. The expenditure incurred for demonstrating the items will be borne by the supplier.**

Specification of Mattress with Cover:-

- Size of the mattress (L X W X H): 198cm X 86cm X 6.4cm (Inflated).
- Should have a patient weight limit of 130 kgs.
- Should be made of Polyurethane material, which is durable & long lasting.
- The One-piece Mattress overlay should have V cell design for comfort and stability of patients and its Cell should be approximately 9 cm in height.
- Should have a cycle time of approximately 10 minutes.
- Should provide low interface pressures under 30 mmHg for an average 55% and under 20 mm Hg for 20% of ten minutes' cell cycle for active pressure relief.
- Cover should be two way stretch, durable & soft to touch. Two washable cover.
- Cover should be impregnated with a specialized coating to make it bacteriostatic, fungi static and mildew resistant and water -resistant.
- End cover should have flaps for secure fixing to the bed base.
- Quick deflate plug should be available for fast deflate in Emergency conditions.
- 5 extra repairing patches with pasting solution must be supply with each mattress.

Specification of PUMP:-

- Should be lightweight & compact with tough durable casing.
- Should have minimum noise & vibration levels and illuminated On/Off switch.
- Indicator for weight adjustment should be available up to 120 kgs.
- Accurate weight indicator for optimum patient support.
- Should have an integrated air filter.
- There should be a visual low-pressure alarm and spring-loaded hanging hooks.

Note:- The Bidder must submit the sample of quoted make for technical evaluation at Administrative Office, Medical College, Second Floor, AIIMS Jodhpur at the time of submission of their quotation. Failure to submit the sample at the time of submission of their quotation/offer will be summarily rejected.
