Quotations must be in the enclosed prescribed format duly signed by the Proprietor/Partner/Director or their Authorized Representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur. Quotation must be in a sealed envelope super scribed with inquiry number.
- 4. Rates must be quoted in "Indian Rupees" and clearly showing taxes, levies, if any. Quotation not conforming to these requirements shall be rejected and no correspondence will be entertained whatsoever.

Scope of Work

- The bidder has to supply install test and commission kirloskar make Bare Pump DB 50/16, Seal Type 86 MOC.
- 2. It is responsibility of the contractor to Supply, Installation, Testing and Commissioning (SITC) of pump at required location, complete with transportation, labour including connection testing etc. as required and nothing shall be paid extra in this account.
- 3. The contractor shall be fully responsible for the safety of all labour/employees employed on the work.
- The contractor shall have to arrange all type of tools and special T&P etc. at his own cost as required to carry out work for which nothing extra shall be paid to the contractor by the department.
- 5. There shall be no liability on the AIIMS Jodhpur to pay any compensations arising out of any labour dispute or accident etc at site.
- 6. Workers engaged by the contractor for execution of work shall be liability of the contractor
- The agency shall be responsible for repair/replacement of defected parts of pump for one year of warranty period from installation and nothing shall be paid extra on this account.
