Sealed Quotations are hereby invited by the undersigned on behalf of the Director, AIIMS Jodhpur for supply of Instrument Trolley for the Institute as per terms & conditions mentioned below. The filled quotations along with all the required document must reach in the office of the undersigned on or before 28.08.2017 05.00 PM. 1. General Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
 - B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
 - C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
 - D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
 - E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
 - F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
 - G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
 - H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
2. The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- Firm shall be registered with the Government of Rajasthan / Central Government.
 - The firm shall have valid GSTIN and IT PAN.
 - **The firm should not be black listed by any Govt. Agency/Dept.**

- J) Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
- K) **Delivery Period** – within 30 days from Purchase order.
- L) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- M) **Payment Terms:** Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the AIIMS Jodhpur.
- N) **Disputes:** -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to the Director, AIIMS Jodhpur whose decision will be final and binding upon the contractor.
- O) **Quantity:** - The quantity of items given in the Quotation is tentative, which may be increased or decreased as per the Institute’s requirement.
- P) AIIMS, Jodhpur reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the AIIMS, Jodhpur will be final in this regard.
- Q) AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.

2. Special Terms & Conditions:

- A. The supplier may be asked to submit a sample of the product(s), which will be evaluated by a technical evaluation committee. The expenditure incurred for demonstrating the items will be borne by the supplier.**

Instrument Trolley

- Overall approx. size: 965mm L x 460mm W x 850mm H.
- Stainless steel square tubes/round tubes.
- Stainless steel top & bottom shelves of 16G thickness, with 3 side railing on top shelf.
- The railing shall be made from dia 10 mm S.S.rod. Only 304 grade stainless steel should be used for trolley frame work and SS shelves
- Trolley mounted on 100mm Dia.castors.
- Stainless steel tubular frame work made of 25.4mm OD x 16 G verticals mounted on 125 mm dia non –rusting castor two with brakes.
- Castor housing and wheels made from high grade non floor-staining synthetic materials with integrated thread guards.
- Wheel centre having precision ball bearing to run smoothly.
- SS parts finished with Matt Polish.
- Load bearing capacity should be at least 20 kg.
