Sealed Quotations are hereby invited by the undersigned on behalf of the Director, AIIMS Jodhpur for Skin Grafting Handle and Attached Blades for the Institute as per terms & conditions mentioned below. The filled quotations along with all the required document must reach in the office of the undersigned on or before 22.09.2023 03.00 PM. The Envelope containing the quotation would please be sealed and super scribed as under:-

**1. Terms & Conditions:**

- A) The quotations received the unsealed and after the deadline not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. **The offer Submitted through Fax/Email shall not be considered and no correspondence will be entertained in this matter.**
- B) Quotations must be in the enclosed prescribed Proforma on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in “**Quotation Box**” located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees (INR)** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) **No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.**
- F) The rates quoted must be valid for 90 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- Firm shall be registered with the Government of Rajasthan / Central Government.
  - The firm shall have valid GST/Other taxes and IT PAN.
  - **The firm should not be black listed by any Govt. Agency/Dept.**
- J) Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.

- K) **Delivery Period** – within **30** days from Purchase order.
- L) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- M) **Payment Terms:** Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the AIIMS Jodhpur.
- N) **Disputes:** -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to the Director, AIIMS Jodhpur whose decision will be final and binding upon the contractor.
- O) AIIMS, Jodhpur reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the AIIMS, Jodhpur will be final in this regard.
- P) AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.

**Specifications for skin grafting handle Watson type**

- Skin graft handle length should be 300 mm, 12.
- Blade and handle should be quoted of same manufacturer
- Instrument should be made of high-grade stainless steel. The quality of steel should comply with the DIN standards.
- It should be of high quality and precision.
- It should be light weight, strong and durable.
- It should be non-magnetic.
- Instrument should be autoclavable.
- The Tungsten Carbide inlay should be nickel based.
- The TC inlay should be welded to the instrument and not pasted.
- Instrument should have bar coding.
- The manufacturer should have a direct repair facility available in India.
- All instruments should be autoclavable at 134 deg.
- Instruments should meet the International Certification as per DIN EN ISO 13845:2001.
- It should have TUV certificate of manufacturer with details of manufacturing facility.
- The instruments should have bar coding for individual tracking of the instruments.
- Instruments should be (European CE and US-FDA) OR (US-FDA AND BIS) CERTIFIED.
- If quoted by other than OEM (Original equipment manufacturer), Tender specific Authorization Letter of OEM is mandatory.
- **All instruments should be supplied from single manufacturer.**

**1. The Bidder must quote single Make.**

The bidder must quote their quotation only in the format as mentioned at **ANNEXURE “2”** on the letter head of firm otherwise quotation will be **REJECTED**.

**2. Catalog must be attached with quotation for technical evaluation.**
