Sealed Quotations are hereby invited by the undersigned on behalf of the Director, AIIMS Jodhpur for Handheld EMG Machine for Botulinum Toxin Injection for the Institute as per terms & conditions mentioned below. The filled quotations along with all the required document must reach the office of the undersigned on or before 05.08.2022 03.00 PM. Terms & Conditions:

- A) The quotations received unsealed and after the deadline will not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. **The offer submitted through Fax/Email shall not be considered and no correspondence will be entertained in this matter.**
- B) Quotations must be in the prescribed proforma (Annexure-2) on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in “**Quotation Box**” located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian Rupees (INR)** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- Firm shall be registered with the Government of Rajasthan / Central Government.
 - The firm shall have valid GST/Other taxes and IT PAN.
- The firm should not be black listed by any Govt. Agency/Dept**
- A) Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.

- B) **Delivery Period** – within 30 days from Purchase order.
- C) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- D) **Payment Terms:** Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the AIIMS Jodhpur.
- E) **Disputes:** -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to the Director, AIIMS Jodhpur whose decision will be final and binding upon the contractor.
- F) AIIMS, Jodhpur reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the AIIMS, Jodhpur will be final in this regard.
- G) AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.

- B) **Catalog must be attached with quotation for technical evaluation.**
- C) The supplier may be asked for demonstration of their equipment for which rates have been quoted, to the AIIMS Jodhpur. The expenditure incurred for demonstrating the items will be borne by the supplier.

SPECIFICATION OF HANDHELD EMG MACHINE FOR BOTULINUM TOXIN INJECTION

- The unit should be Handheld “PDA Sized” Device.
- The weight of the complete unit should not be more than 400 gms (including batteries)
- Should provide functionality of EMG and stimulation in same device.
- Should provide muscle localization to accurately guide and monitor injection of medicinal product.
- Should provide EMG recording with audio and stimulation while injecting any drug with single needle electrode.
- Unit should be 9V rechargeable battery powered.
- Should provide EMG with audio and stimulation ranging from 0 – 15 mA
- Should have built in speaker with volume increase / decrease facility.
- Should have 2 reference inputs.
- Should have touchproof connections available on the unit.
- Recording electrode should be plugged directly on to touchproof connection of main unit without any loop cable.
- Should have adjustable stimulus duration of 0.1 ms & 0.2ms.
- Should have adjustable stimulus frequency of 1Hz or 2Hz.
- Should enable to hear EMG audio to guide the site before any drug is injected.
- The product should be US FDA/CE approved. Certificate should be attached with product details..
- The product should be IEC60601/2 or equivalent certified for patient safety.
- Technical /Clinical demo is required on installation.
- Warranty : Min 1 Year

Note:-

1. The bidder must quote **single Make**.
2. **Authorization certificate should be submitted.**
3. The bidder must quote their quotation only in the prescribed format (Annexure 2) on the letter head of firm otherwise quotation will be **REJECTED**.
4. Catalog must be attached with quotation for technical evaluation.
