#### NOTE:-

- 1. The above vacancies are provisional and subject to variation. The Director, AIIMS, Jodhpur reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
- 2. Reservation will be as per Government of India Policy.
- 3. 3% vacancies are reserved for physically handicapped (PH) candidates.
- 4. Candidates may kindly take note:
  - **Candidates having MD/DNB in Paediatric or Medicine** can also apply for the post of Senior Residents in the Department of Cardiology, Endocrinology and Nephrology.
  - **Candidates having MS/DNB in General Surgery** can also apply for the post of Senior Residents in the Department of Paediatric Surgery, Surgical Oncology and Cardiothoracic Surgery.

#### 2. <u>UPPER AGE LIMIT AS ON (31/10/2016)</u>:

- a) For eligibility to apply for these posts upper age limit as on **31/10/2016** will be 33 years. This is **relaxable** for **SC/ST** candidate for a maximum period of **five years**. In the case of **OBC** candidates it is relaxable upto a maximum period of **three years**. In the case of Orthopaedics Physically Handicapped **(OPH)** candidates, this is relaxable upto maximum period of **10 years for General Category**, **13 years** for **OBC** category and **15** years for SC/ST category candidates.
- b) For those applying for these posts after completing DM/M.Ch Courses, the upper age limit as on **31.10.2016** will be **35 years**. The age limit is further relaxable for **SC/ST** candidates, **OBC** candidates & **OPH** candidates as above.
- c) In cases where result of qualifying exam is declared after **31/10/2016**, their candidature will stand cancelled and no claim for selection.
- d) The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of Interview. The candidates will not be permitted for Interview if they fail to produce no objection certificate on the day of interview during scrutiny of documents.

#### **APPLICATION FEE:**

- i) For OPH Candidate: NIL
- ii) General/OBC category: ₹ 1,000/-.
- iii) SC/ST category: ₹800/-.

#### **PAY SCALE**

Senior Resident (Medical): ₹ 15,600-39,100+6,600 (Grade Pay) + NPA (Non Practicing Allowance) plus other usual allowance. NPA is not applicable to non-medical candidates.

#### RESERVATION FOR SC/ST/OBC/OPH SHALL BE APPLICABLE AS PER GOVT. OF INDIA POLICY.

Reservation for Orthopaedics Physically Handicapped Candidates is **3%** which will be provided on horizontal basis to OPH candidate in their respective categories.

#### Criteria for Orthopaedics Physical Handicapped:

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and countersigned by Medical Superintendent / CMO / Head of Hospital / Institution.

Candidate applying in OBC/SC/ST Category, must possess the caste certificate issued by competent authority, valid for admission/Job in Central Govt. Institutions issued before the date of interview, failing which <a href="height:he/she shall not be allowed to appear in interview for the same category">he/she can be treated as UR Candidate.</a>

OBC certificate must have been issued in last one year.

In case of OBC candidate, should belong to non-creamy layer of Central List of OBC.

In case candidate fails to produce valid OBC certificate for admission / Job in Central Government Institution or issued within one year at the time of interview / document verification his candidature will stand cancelled.

#### 3. **DATE AND VENUE:**

Interview will be conducted on 02<sup>nd</sup> November, 2016 (Wednesday) and 03<sup>rd</sup> November, 2016 (Thursday) at 10.00 am at Medical College of AIIMS, Jodhpur (Rajasthan).

#### 4. **SELECTION PROCEDURE:**

The selection will be on the basis of the interview. The list of selected candidates will be uploaded on website. Candidates are advised to check the Institute website regularly for information.

- j) No Objection Certificate in case of Govt. / Semi. Govt., PSU Employee.
- k) Reservation category Certificate (OBC\*/SC/ST/PH) (\*Candidate should belong to non-creamy layer of Central List of OBC).
- l) Publications.
- m) Any other relevant documents

# Annexure 'A' TERMS & CONDITIONS

**Tenure:** - The appointment for a period of 11 months or upto next regular Interview, which is the earlier. This appointment will not vest any right to claim by the candidate for permanent absorption in the institute OR for continued contractual appointment which may be renewed or terminated as decided by the Institute.

**Remuneration**: - The appointment will entitle the appointee to a remuneration as mentioned.

**<u>Leave</u>**: - The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.

The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.

The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.

This appointment is whole time and private practice of any kind is prohibited.

He/She will have to work in shifts and can be posted at any place in the Institute.

He/She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.

No travelling or other allowances will be paid to the candidate for joining the post.

The candidate should not have been convicted by any Court of Law.

Canvassing in any form will render the candidate disqualified for the post.

If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he / she will be liable to be removed from services and such action as the appointing authority may deem fit.
